

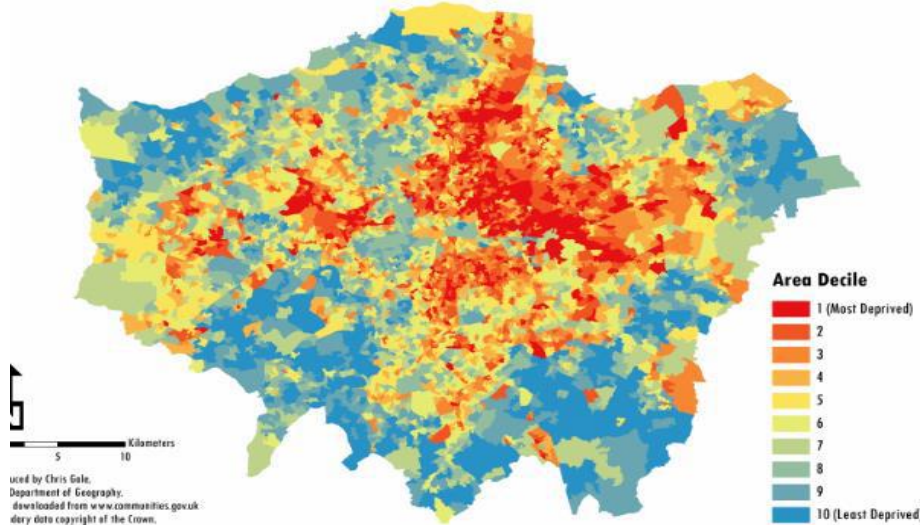

that threaten a city

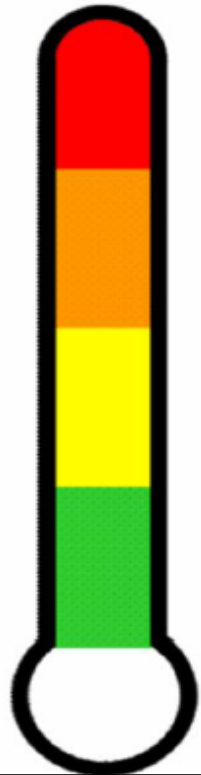


CHRONIC STRESSES

MEDIUM

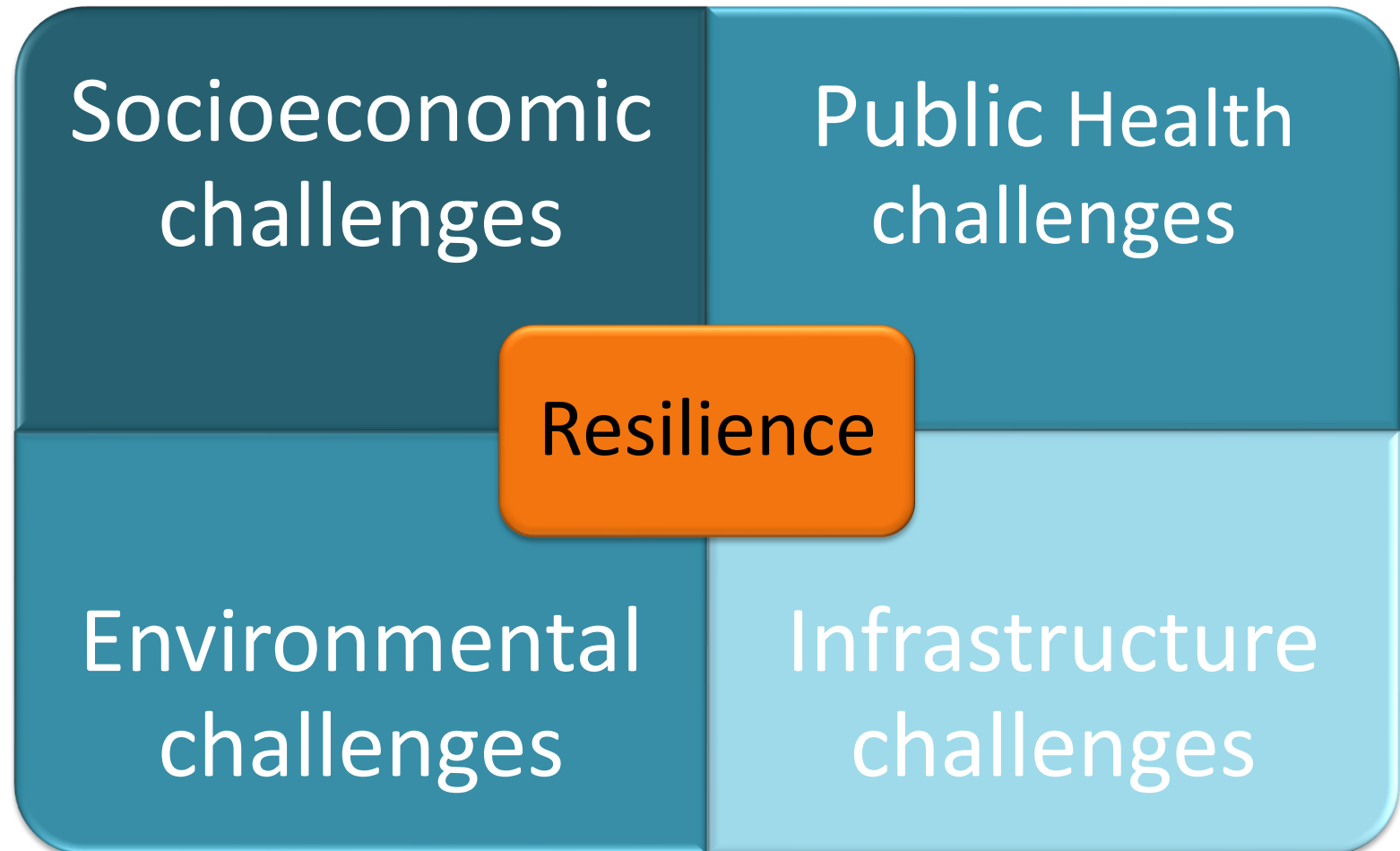
